

Steps to Completing your EIN Application Online

- 1. Click on the <u>on-line EIN application</u> link to get to the IRS page then click on on-line EIN application on that page.
- 2. 10. You may request either to receive a PDF online version of your EIN confirmation letter OR to receive your EIN confirmation letter by mail. Send a copy of the EIN confirmation to AIUSA. After you have been issued

an EIN, you "may" receive an employee wages reporting forms from the IRS. While at first glance the number and initial supply of these forms mailed out by the IRS may appear daunting, you may report "no employees," and check the box which reads "this is my final report."
