Emilio Gutiérrez Soto is a Knight-Wallace Press Freedom Fellow at the University of Michigan. A Mexican journalist seeking asylum in the U.S., he left Mexico in 2008 to escape death threats linked to his reporting on military corruption in his home state of Chihuahua. Prior to fleeing his country he worked as a journalist for more than twenty-five years, as a newspaper and radio reporter and a magazine editor, covering everything from crime to politics to the arts. In December 2017, after more than a decade of legal limbo, Gutiérrez and his son were detained by U.S. Immigration and Customs Enforcement (ICE) in El Paso, Texas and were held in detention for nearly eight months. Mexico is now one of the deadliest countries in the world for journalists. As a Knight-Wallace Fellow, Gutiérrez is studying issues related to the freedom and safety of the press while he awaits a resolution to his case.
