Biographical Statement: I am a citizen of Cherokee Nation and I work at the intersection of federal Indian law and international human rights. Originally from Oregon, I went to Swarthmore College and then graduated from Temple Law in 2012. After a year as a stay-at-home father, I joined the Indian Law Resource Center (ILRC) where I am now a senior attorney—I split my time between the ILRC's Montana office and Philadelphia. The

ILRC is a non-profit, founded and directed by Native Americans. We provide legal assistance to indigenous peoples throughout the Americas to combat racism, to protect their lands, to achieve genuine self-government, and to realize their other human rights. My work is centered around indigenous women's rights. I use advocacy at the UN and the OAS to place violence against indigenous women within a rights-based framework that allows us to connect indigenous women's individual rights to live lives free of all forms of violence and discrimination with indigenous peoples' collective rights to land and to self-determination and self-government.

Candidate Statement: After nearly 10 years at the ILRC, I have developed significant expertise in international human rights, indigenous rights, women's rights, and business and human rights, and I have a great deal of practical experience at the UN and OAS, all of which will inform my work for AIUSA. Further, I believe it is essential that our leading human rights organizations, like AIUSA, incorporate indigenous perspectives into their work, both to ensure that they broadly reflect the people they seek to serve, and to help inform their program work and choices. Indigenous rights are still poorly understood even within the human rights community, and I believe my experience would be valuable to AIUSA both as an institution working in this field, and as an institution that is seeking to instantiate equity in itself.

At my first AI Meeting in 1988 then Secretary General Ian Martin handed out pocket-size copies of the UDHR and told us to always keep it with us. The centrality of that document to my has never waned. Reading it today confirms that we are facing the greatest threat to human rights – both to the legitimacy of the ideal of and the respect for inalienable, fundamental rights for all people *everywhere* – since World War II.

Internationally and in the United States, large segments of the population are today increasingly dismissive of and even hostile to human rights. Russia's open commission of crimes against humanity in Ukraine is occurring precisely because so many countries have for decades blatantly violated HR with impunity – the US and its allies as much as its adversaries and countries in between.

I believe Amnesty International plays a crucial role in counteracting this trend, by demonstrating how and why human rights are central to our collective survival at this literally historic tipping point. As a scholar of Africa and the Middle East with a long background in human rights and Indigenous struggles, as well as a Grammy and Guggenheim-winning professional musician, author, journalist and activist, I am uniquely positioned to contribute to Amnesty's effort to navigate this treacherous period, and to create a holistic, future-oriented human rights discourse.

My focus will be on four areas:

- defend human rights as the guiding principle of law, diplomacy and politics;
- advocate for those whose human rights are systematically violated, at home and abroad;
- collaborate with organizations, artists and movements across civil society and the public sphere to raise awareness about and support for human rights; and
- globalize the struggle from below, following the lead of Indigenous and grass roots communities and strengthening international human rights institutions.

My entire professional trajectory was shaped by the human rights violations of that period. Since then, I have worked in two local groups before co-founding group 1016 in Providence. I am also the Legislative Coordinator for RI, where I routinely meet with members of Congress, including Senator Reed and Representative Cicilline, on key human rights issues.

Refugees. Gun violence. Torture. Execution. Trauma. Each has touched me throughout my life. My dad was a refugee from Soviet controlled Ukraine. At age twelve, he escaped a firing squad and hid in a cellar for three months. A year after being denied asylum in USA he took a freighter to Cuba, became a Cuban citizen and at 14 emigrated to the US. His trauma

symptoms were no surprise and it affected me all my life.

I joined Amnesty to honor my father, who taught me freedom brings the obligation to work against oppression. I have continued my work to honor the victims of human rights violations I saw on death rows and in refugee camps. And no child should be forced to flee their country, or stare down the barrel of a gun.
