Leonard Peltier, a Native American activist, has been imprisoned for nearly 50 years in the USA for a crime he maintains he did not commit. FBI agents Jack Coler and Ronald Williams were killed in a gunfight on the Pine Ridge Indian Reservation in 1975. We have the deepest sympathy for their relatives. However, we have examined Leonard Peltier's case extensively over many years, sent observers to his trial in 1977, and remain seriously concerned about the fairness of the proceedings leading to his conviction, and believe that political factors may have influenced the way in which the case was prosecuted. Tribal Nations, Nobel Peace Laureates, former FBI agents, and even the former U.S. Attorney whose office handled the prosecution have called for his release. Now 78 years old, he suffers from several chronic health ailments that could be fatal. We urge President Biden to grant Leonard Peltier clemency on humanitarian grounds and release him.

## BACKGROUND ON LEONARD PELTIER'S CASE

Leonard Peltier, an Anishinaabe-Lakota Native American, was a member of the American Indian Movement (AIM), which promotes Native American rights. In 1975, during a confrontation involving AIM members on the Pine Ridge Indian reservation, FBI agents Ronald Williams and Jack Coler were shot dead. AIM member Joseph Stuntz was also killed. Leonard Peltier was convicted in 1977 and sentenced to two consecutive life sentences related to the murder of agents Jack Coler and Ronald Williams. Leonard Peltier has always denied killing them.

Amnesty International does not take a position on whether Leonard Peltier is innocent or guilty. Amnesty International's position is that, given the totality of the circumstances, including the serious concerns about the fairness of the trial and legal process leading to Leonard Peltier's conviction, his time served, and serious health concerns, that the interests of justice are best served by clemency and his release.

Concerns about the fairness of the legal process include the FBI's intimidation of witnesses and coercion of their testimony, refusal to allow certain witnesses to testify on behalf of Leonard Peltier, the suppression of evidence which may have assisted in Leonard Peltier's defense, and bias against Native Americans

which may have influenced the trial, among other issues.

Even the U.S. Attorney, James H. Reynolds, whose office handled the prosecution and appeal of Leonard Peltier's case now calls for his release. In a letter to President Biden, he wrote, "With time and the benefit of hindsight, I have realized that the prosecution and continued incarceration of Mr Peltier was and is unjust...I urge you to commute Leonard Peltier's sentence and grant him executive clemency."
