## RELEASE ARBITRARILY DETAINED JOURNALIST

On February 24, a journalist named Blessed Mhlanga was arrested. He was accused by authorities of sharing messages that could cause harm and violence. Prior to his arrest, he interviewed people who criticized the president of Zimbabwe. Blessed must be freed immediately and unconditionally because he was only using his right to freedom of expression. His arrest is unfair and goes against the laws protecting and respecting the human right to freedom of expression and freedom of the press.

## **Learn More About Blessed**

Blessed Mhlanga is a journalist in Zimbabwe. Under **International Human Rights Law**, specifically Article 19 of The Universal Declaration of Human Rights, journalists are protected by the right to freedom of expression, including the right to **seek**, receive, and share information.

On February 21, the police in Zimbabwe started looking for Blessed. They said he broke the law by sharing messages that could cause harm and violence. On February 24, Blessed went to the police station to settle this matter, and they arrested him. On February 25, a court decided he could not go home while waiting for his **trial**, which will start on April 4, 2025.

This isn't the first time Blessed has had trouble because of his work as a journalist. In May 2022, he was arrested after filming the police arresting someone. Although Blessed said he was a journalist, the police still arrested him, broke his phone, and hurt him. Later, he was found not quilty.

Zimbabwe has laws that give everyone the right to speak freely and protect journalists. For example, they signed The Universal Declaration of Human Rights, meaning Zimbabwe must be committed to promoting and protecting human rights. These rights are also supported by agreements Zimbabwe has made with other countries. These agreements say everyone should be able to share ideas and opinions freely without fear.
